

- <u>30-60-90 Day Plan:</u> if you're having trouble knowing where to start, a short-term plan and task list might help to prioritise key activities and outcomes
- <u>Business Plan Template</u>: there are many different versions of business plans. Consider what you need it for and who you are presenting it to before deciding what information you'll need to include. This is a basic example to get you started.


